Notice Regarding Acquisition of Treasury Shares

Exeo Group, Inc. hereby announces that the company, at a meeting of the Board of Directors held on February 9, 2024, has decided to acquire its common stock pursuant to Article 156 of the Corporation Law of Japan, as applied pursuant to Paragraph 3, Article 165 of the Corporation Law, as described below.

1. Reasons for acquisition of treasury shares

To enhance shareholders' return by facilitating flexible implementation of capital policy and enhancing capital efficiency.
