Notice Regarding Acquisition of Treasury Shares

(Acquisition of treasury shares under the provisions of articles of incorporation pursuant to Paragraph 2, article 165 of the Corporation law of Japan)

Exeo Group, Inc. hereby announces that the company, at a meeting of the Board of Directors held on May 9, 2025, has decided to acquire its common stock pursuant to Article 156 of the Corporation Law of Japan, as applied pursuant to Paragraph 3, Article 165 of the Corporation Law, as described below.

 Reasons for acquisition of treasury shares
 To enhance shareholders' return by facilitating flexible implementation of capital policy and enhancing capital efficiency.

2. Details of the acquisition

(1) Class of shares to be acquired: Common stock

(2) Total number of shares to be acquired: Up to 2,400,000 shares (Equal to 1.16% of total issued shares excluding treasury shares)

(3) Total amount of shares to be acquired: Up to 3,000,000,000 yen

(4) Acquisition period: July 1, 2025 ~ March 31, 2026

(5) Acquisition method: Market purchase on the Tokyo Stock Exchange
